It is not required that you complete the Referee module if you are a new or Provisional umpire. We recommend that everyone else completes the Referee module because we are asked at times to fulfill those duties at tournaments.

• MTO's when No Qualified Medical Person is Available. Start first clock as soon as you are aware the player has stopped playing from an injury. There is no evaluation time (up to 2 minutes). Start next clock for 3 minute treatment AFTER you explain the treatment regulations to the player, get supplies to the court for them to treat injury. Once treatment starts they have only 3 minutes to treat the injury. Once treatment is complete announce TREATMENT COMPLETE, stop treatment clock and determine if player is able to continue play. If so allow time to clean up area, get shoes on, throwaway garbage, etc. then announce TIME. Turn off first clock.

There are many different scenarios for MTO's. Please read over the Medical Time out Procedure table in your FAC often if you are not familiar with them. Many players out there are uncertain of the time allowed for treatment and are looking to us to guide them.
