2018 RE-CERTIFICATION DEADLINE FRIDAY NOV. 10

To process your 2018 Certifications you will need to,

- -Complete Learning Courses by Nov. 10,
- -Record work records on NUCULA,
- -Click the RE-certification Request button.
- -Confirmation from USTA that they have received your Vision form. **Deadline to** send Vision forms is DEC. 1, 2017

Correction to earlier notice: **Reminder:** Events should not be entered into your work record until after you have worked them. If these events affect your 2018 certification level, you can submit a certification appeal beginning **January 1**, **2018**.

2018 PNWTOA MEMBERSHIP DUES AND HOURLY RATE INCREASE

Membership is open to all certified and prospective tennis officials. The membership year is January 1 to December 31. Dues: \$30 per year.

Membership is required to vote in Association elections and serve on the Board of Directors and Association committees. **Solicitations for USTA and ITA assignments will require Association membership.** Membership also includes the ability to post to the discussion blogs on the website and be notified of website updates.
