2023 USTA/PNW contract changes were sent to Valerie Weaks on September 30. Subsequent to this
submission, it was discovered that the 2022 contract was changed by PNW to require the TOA to
handle payment processing to individual officials, which has major operational and tax consequences
that TOA is not prepared to take on. An emergency board action was unanimously approved to restore
the original 2021 contract wording, along with the addition of a 30 day timely payment to Officials
provision by PNW. The full wording of the action is included at the end of the minutes.

#### **New Business**

- -- **Website Maintenance:** Mitch is grateful for offers of helping to update the website, which has been done with much help from Denise in the past. A free Wordpress account login is required to gain administrative access to the website. Mitch will email info to interested parties on how to sign up.

# **Emergency Board Action: October 12, 2022**

I, the undersigned Pacific Northwest Tennis Officials Association Director, endorse taking the following action between our regular Board meetings of October 2022 and November of 2022:

Update the Board's suggested changes in its 2023 contract with USTA/PNW to remove the following language:

"TOA will bill USTA/PNW for the total services provided by its Officials and Referees, invoicing in sufficient detail the services rendered and amount owed for the services of all Officials and Referees, as described in the fee schedule below. Payment by USTA/PNW to TOA in a lump sum payment for all the services of all invoiced Officials and Referees will be due within 30 days of receipt of the invoice."

And restore this language from 2021 and years prior:

"The USTA/PNW shall pay Official or Referee a fee for service at the rate(s) described in the fee schedule below. Payment shall be due within 30 days of the receipt of the Official's invoice."
